On January 20, 2021 Premiere Career College signed and submitted to the Department of Education the Certification and Agreement and the assurance that the institution intends to use no less than 100 percent of the funds received under 314(a)(4) of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) to provide Emergency Financial Aid Grants to students.

Premiere Career College has received, as of February 4, 2021, \$334,793.00 from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students.

As of September 30, 2021, Premiere Career College has distributed \$334,793.00 in Emergency Financial Aid Grants to students. The remaining 20% of its allocation was disbursed during this last period.

At the time of disbursement, there were 47 students at the institution that were eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA (a)(4) program.

As of June 30, 2021, 184 students have received an Emergency Financial Aid Grant under the CRRSAA (a)(4) program.
